

# TERMS AND CONDITIONS – SIDE TABLE 606, ANNIVERSARY EDITION, MINT GIVEAWAY

## 1 GENERAL

## 2 WHO CAN PARTICIPATE IN THE CAMPAIGN?

To qualify as a participant in the Campaign:

- (i) you must be at least 16 years old
